**Motion #2018-59:** A motion to approve the July 18, 2018 meeting minutes and the August 9, 2018 special meeting minutes was made by John Boyea and seconded by James Bowen. All members were in favor.

## Financial Services/Programs

- 1. Monthly Loan Report & Defaults
  - a. Westport Golf & Hospitality (Westport) Need to discuss with Ron Briggs and follow up to confirm Guarantor proceeded against Consolidated Mortgage.
  - b. Adirondack Meat Company (Ticonderoga) IDA has been notified that Pineland Farms has withdrawn offer on building due to size of facility not accommodating their proposed equipment and lack of finding General Manager. At this time the IDA will need to discuss further default proceedings against Adirondack Meat Company and guarantors.
- 2. Straight Lease Back Transactions:
  - a. Pre-Tech Plastics (Moriah) application Jen Briggs is finalizing deed and mortgage. Squires Sanders finalizing PILOT Agreement. Hoping to close in September. As per the Contract for Purchase the Essex County IDA finance \$480,000 mortgage request. An underwriting summary was provided to the board for review.

**Motion 2018-60:** A motion to approve the mortgage request of \$480,000 with \$5,000 deposit and \$45,000 due at closing, term of 10 years with 15-year amortization and a \$3,088.84 loan payment each month, Rick Dolliver as guarantor with IDA as  $1^{st}$  lien on building and property. Motion was made by

John Boyea and seconded by James Bowen. All members were in favor.

#### **Business Park Development**

- 1. Moriah Business Park
  - a. Lot #4 Building (High Peaks Hospice) Lease Renewal The IDA is working with CV-TEC to coordinate work for fall semester and completion of the lot #4 additional office space by January 1, 2019. The Essex County IDA will be utilizing the building trades class for the renovation project and also the environmental science class for the excavation of the remaining detention basin as well as potential clearing on lot #7.

**Motion #2018:61:** A motion to renew the CV-TEC contracts for the 2018-2019 school year with the building trades class as well as the environmental science class was made by Matthew Courtright and seconded by Darren Darrah. All members were in favor.

b. Lots #3, #5 & #6 (Whistlepig) – Jen Briggs working on the closing documents for the Lot #6 purchase. During the review of this purchase, Moriah Ventures attorney has requested an amendment to the existing Moriah Business Park Covenants & Restrictions noting the following addition under prohibited uses "This provision shall not prohibit the distillation, processing and storage of alcohol and its related bi-products as to any activity on all lots now owned or hereafter acquired by Moriah Ventures and its successors and assigns."

**Motion #2018-62:** A motion to approve amendment to the Moriah Business Park Covenants & restrictions was made by Jamie Rogers and seconded to James Bowen. All members were in favor. As per amendment, the Essex County IDA, Town of Moriah as well as Moriah Ventures will need to execute document and record in the Essex County Clerk's Office.
