## **Essex County Capital Resource Corporation Mission Statement and Measurement Report for 2020**

Name of Public Authority: Essex County Capital Resource Corporation

The purpose for which the Corporation is to be formed and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, is to lessen the burdens of government by fulfilling the purposes now or hereafter referred to in Section 1411(a) of the NFPCL including, without limitation, by means of engaging in the following activities: (a) promoting community and economic development and the creation of jobs in the non-profits and for profit sectors for the citizens of the County by developing and providing programs for non-profit institutions, manufacturing and industrial businesses and other entities to access low-0interst tax-exempt and non-tax-exempt financing for their eligible projects; (b) issuing and selling one or more series or classes of bonds, notes and other obligations through public letting, private placement, or negotiated underwriting to finance activities referred to in subparagraph (a) above, on a secured or unsecured basis; (c) engaging the services or one or more underwriters, placement agents, consultants, attorneys, financial advisors and other person whose services may be appropriate or desirable in connection with the acquisition and financing referred to above; (d) undertaking projects within the County that are appropriate functions for a non-profit local development corporation for the purpose of relieving and reducing unemployment, promoting and providing for additional and maximum employment, bettering and maintaining job opportunities, carrying on scientific research for the purpose of aiding the County by attracting new industry to the County or by encouraging the development of or retention of an industry in the County, an lessening the burdens of government and acting in the public interest; and (e) in general, performing any and all acts and things, and exercise under and pursuant to the laws of the State of New York for the purpose of accomplishing any of the foregoing purposes of the Corporation (corporation established June 17, 2010).

<u>Public Authority's Mission Statement:</u> Our mission is to create a viable business atmosphere that will attract compatible and diverse sustainable economic development opportunities while focusing on major assets, retention / expansion projects, quality of life and job creation.
