Open of Meeting

The meeting was opened by Chairman Darren Darrah at 10:00AM.

Approval of Minutes

Motion #2019-53: A motion to approve the September 4, 2019 meeting minutes, September 18, 2019 special meeting minutes and the October 8, 2019 special meeting minutes was made by James Monty and seconded by Gerald Morrow. All members were in favor.

Project Presentation

1. Trailhead Resort (Newcomb) PILOT Application – Kelly Audino was present on conference call to discuss proposed application and request for Schedule A 10-year PILOT. Project construction is just wrapping up and the request for incentives would allow business to reduce their overhead expenses in first few years to establish sales. Current assessment of property is \$150,800 and final assessed value will be \$850,000. Total investment in project is \$1 Million, project expected to create 2 FT, 13 PT in year 1, ,1 FT & 7 PT additional by year 3. Kelly noted that their Department of Health inspection is scheduled for tomorrow. Business liquor license application has been submitted and temporary license also applied for. Certificate of occupancy from the Town is needed but project has been working closely with the Code Enforcement Officer. The projected PILOT savings for Schedule A of PILOT is \$120,593.81 over 10 years. IDA staff and business have met with the Town of Newcomb to discuss proposed PILOT and the Town and School will be meeting next week to review and approve. In review of the proposed savings, there was an effort to reduce the closing costs associated with the transaction and legal counsels have agreed to reduce their fees in order to increase incentives provided.

Motion #2019-54: A motion to approve the PILOT application for Trailhead Resort (Schedule A PILOT for 10-year term) was made by John Boyea and seconded by James Bowen. All members were in favor.

Motion #2019-55: A motion to set the IDA transaction fee for PILOT application at \$5,000 was made by James Bowen and seconded by Darren Darrah. All members were in favor.

Motion #2019-56: A motion to schedule the Public Hearing for December 18, 2019 at 9:00AM was made by Gerald Morrow and seconded by Darren Darrah. All members were in favor.

Applications will be due by February 2, 2020. \$5,000 to \$20,000 grants to be awarded.
