Approval of Minutes

1. April 30, 2015 Meeting Minutes

Financial Services/Programs

- 1. Straight Lease Back Transactions
 - a. Northwoods Inn (North Elba) Jody Olcott toured the site and was astonished with renovation and transformation. Bookings for 2016 are already exceeding their projections. Sales tax exemption will end at the end of the month.
- 2. Monthly Loan Report (June 17, 2015) Report was distributed to the board. Normandie Beach Club is one month behind. Westport Country Club and Hospitality is two months behind and if not current will be required to attend next board meeting.
- 3. Bodette's Barbeque (Ticonderoga) Bodette's Barbeque is requesting an \$18,000 loan at 4% interest for 5 years with secured collateral position as 2nd mortgage on property at 133 Montcalm Street. The IDA has existing Lake Champlain Bridge loan with Joe & Cindy Bodette with a balance of \$5,763.52 which is current. Joe Bodette noted that since opening the actual sales have exceeded projections. The business will be for 10 months each year and currently has five employees. Business is working with bank to get temporary financing until IDA loan closes.

Motion #2015-33: A motion to approve the loan request in the amount of \$18,000 at 4% for 5 years with a 2nd mortgage on the property at 133 Montcalm Street was made by Gerald Morrow and seconded by Charles Bryant. All members were in favor.

An actual project cost summary to date was distributed to Board for review, noting that prevailing wage rates (labor) and materials were separated on the summary to shown the impact of these high wages on the overall budget. High Peaks Hospice will be moving in next week as Time Warner Cable is now finishing fiber optic installation.
