- a. 2017 Financial Audit/Presentation by Barbara Dwyer The Board met as a whole to discuss 2017 financial audit which would also be used as audit committee meeting. Overview of Presentation:
 - Barbara Dwyer met with Jen Briggs to discuss loan default status for the following loans: Earthmuffins – judgement expired 2017, Stephano's – Bankruptcy wiped IDA out, Normandie – Bankruptcy wiped IDA out, and Adirondack Meat Company – Bad dept expense increased due to business closure.
 - IDA bond revenue income increased due to the multiple bond transactions for 2017.
 - IDA administration of the 2nd round of the micro-enterprise HUB grant impact was significant.
 - Whistlepig project highlighted and construction of 3 buildings in 2017.
 - Retirement reported in notes and change in reporting requirements

Motion #2017-23: A motion to approve the January 24, 2018 meeting minutes and the February 6, 2018 special meeting minutes was made by Gerald Morrow and seconded by Matthew Courtright. Darren Darran abstained from January & February meeting minutes. James Bowen abstained from January meeting minutes. Motion passes.

Financial Services/Programs

- 1. Monthly Loan Report
 - a. Defaults: Westport Golf & Hospitality (Westport) Based on the Loan Repayment Agreements previously approved and executed, the IDA has received \$15,000 check from Rod Edwards and an additional \$15,000 from Como Oil. As per Agreement Como Oil must pay \$7,500 or \$15,000 to IDA in 2018. IDA has filed judgement against John & Lynn Hall. Adirondack Meat Company (Ticonderoga) Briggs Norfolk filed summary judgement against Pete & Denise Ward in Florida. At the time of inspection in February, the equipment purchased with IDA loan proceeds was not present in the building at time. Business owners claim equipment is in storage but this has not been verified. Glens Falls National Bank is appointing a receiver to administer loan and building options. IDA Board directed Briggs Norfolk to pursue criminal charges if the equipment purchase with IDA loan proceeds and secured with UCC statement has been sold.
 - b. Big Slide Brewery At this time the business is 3 months in arrears and a March 15, 2018 email from the business was received and distributed to Board for review. Email notes temporary working capital shortage due to short term terms for food & equipment. Business would like time to complete 2017 financials and work on repayment restructure request.

Motion #2017-24: A motion to approve January – April deferral of principal only with late fees and interest due at time letter is received and requirement at April meeting with a loan restructure plan was made by Jamie Rogers. All members were in favor.

2. Straight Lease Back Transactions

a. Paradox Brewery (North Hudson) – February 15th closing. Construction contracts awarded last week working on sales tax administration with the multiple contractors awarded.

Business Park Development

 - a. Lot #1 Building (Pre-Tech Plastics) Pre-Tech indicated contract should be received this week. An ice jam issue over entrance was corrected with new heat tape and gutter.

 - d. Lot #7 Appraisal Board has reviewed appraisal of lot #7 completed by Adirondack Appraisal Services. IDA/AES Northeast will contact APA to discuss wetland mapping for Spring on 15 acres.
