Open of Meeting

Motion #2020-98: A motion to approve the August 25, 2020 meeting minutes, September 2, 2020 special meeting minutes and September 29, 2020 meeting minutes was made by John Boyea and seconded by Matthew Courtright. All members were in favor.

Financial Services/Program

- 1. Monthly Loan Report A November 9, 2020 report was distributed to the board noting Salt of the Earth previous loan is paid in full, leaving the remaining COVID-19 loan. - 4. COVID-19 Emergency Loan Update Last remaining loan to Denton's Bear Necessities closed in October. There are now 9 active loans.

Business Park Development

 - a. Lot #4 Building (High Peaks Hospice) Parking lot topcoat and striping completed
 - b. Lots #3, #5, #6 & #8 (Whistlepig) Jody met with Whistlepig last week to discuss future expansion and their needs. The IDA, Whistlepig and AES Northeast to meet on-site this

- week to review new property expansion opportunities, existing stormwater management and infrastructure needs.
- c. New Property Expansion APA completed wetland mapping and AES overlaid on survey/topo. Unfortunately from the mapping it appears that the property to the west is undevelopable, leaving approximately 16 of the 38 acres to the east for development.

 - a.
