Town of North Elba COVID-19 Business Emergency Grant Program

1. Grant Review Committee Recommendations:

Adirondack Foot Sanctuary - \$15,000 (Requested \$15,000)

Dancing Yogini LLC, dba The Studio Upstate - \$15,000 (Requested \$15,000)

The Grant Review Committee that the IDA appointed, met on June 29, 2021, to evaluate and score each application. Carol Calabrese said part of the discussion with the Grant Review Committee was if any committee member felt there may be a "conflict of interests" and how to evaluate and proceed with the process. Carol also asked the committee to take notes.

The IDA Board had questions regarding Keyes Financial and the reasoning behind receiving \$0 in grant funding. As the Grant Review noted "Keyes Financial received the lowest ranking and it was agreed that he really didn't suffer an injury even though his revenues were down, since they were still quite high and he got a considerable amount of other monies."

Jamie Rogers reclused himself.

Witherbee Carriage House

The IDA staff received an email from Patricia Christian requesting a release on one of the lakefront access properties that the IDA has a lien on. The balance of the IDA loan is \$11,488.27. Witherbee Carriage House is also seeking a release of another lot from Lake Champlain Lake George RDC with a \$38,846.71 loan balance and Schroon Lake RLF with a \$11,254.37 loan balance. The IDA will still hold a co-proportional lien on the Witherbee Carriage House restaurant building and 2 other lakefront access properties with LCLGRDC and Schroon Lake RLF.

Motion #2021-55: A motion to approve a release on one of the lakefront access lots that the IDA holds a lien on to the Witherbee Carriage House was made by James Bowen and seconded by Jamie Rogers. All members were in favor.

Website - Update

IDA staff updated the board on the website development and requested a second RFP from Ken Hughes owner of The McMan consulting. Unfortunately, Ken Hughes was unable to assist the IDA at this time and issued a no bid to the RFP.
